

## Actual proposed text amendments/changes to BY-LAWS

### **Article III, “Participants”**

*“Any person, regardless of town residency or enrolled school district may participate in the any of the Club’s programs.”*

### **Article IV, “Membership”**

**Section 4.1 “Voting Membership.”** All parents of players (under the age of 18) who participate in the *“intra-club (recreational), travel, or premier programs;* all players 18 years of age or older; and any officer, director, *or* coach, [ delete supporting members] may vote in general membership meetings.

**Section 4.2 “Supporting Membership”.** Delete section in its entirety

**Section 4.3 “Parents”.** Renumber **Section 4.2.**

**Article VII, Section 7.6, “Assigned Duties”.** Every Director shall be *either elected as an officer (co-officer) of the Club or chair a designated committee during her/his term on the board.*

**Article VIII,** *In the event that the office of Co-President becomes vacant between elections, the Vice President, elected first, hence the First Co-Vice President will fill the vacancy until the next scheduled AGM.*

**Section 8.1 “Officers”.** *“The officers of the Club shall be Co-Presidents, [delete president-elect], Co-Vice Presidents, Co-Secretaries and Co-Treasurers.”* Co-officer holders’ terms shall be staggered so that no position shall have two individuals duly elected at the same AGM meeting.

**Section 8.2 “Terms”.** *“The term of office for each of the co-officers shall be two years and until the election of a successor.”* As two second sentence of Section 8.2, the proposed amendments are as follows:

- a. Delete sentence in its entirety.
- b. *“No officer shall serve more than two consecutive terms in the same office unless by a majority vote of voting membership in attendance at the meeting in which the vote is held.”*
- c. *“No officer shall serve more than two consecutive terms in the same office unless by a two-thirds vote of voting membership in attendance at the meeting in which the vote is held.”*

**Section 8.5 “President”. Amend to “Co-President”.** “The *First elected Co-President* shall preside at all meetings of the membership and of the Board of Directors and perform such other duties assigned by the Board of Directors.” *In the event that the office of First Co-President becomes vacant between elections, then the Second Co-President will fill the vacancy until the expiration of his term as Co-President.*

**Section 8.6 “President Elect”.** Delete in its entirety.

**Section 8.7, “Vice President”** Amend to “**Co-Vice Presidents**”

The *Co-Vice Presidents* shall act in the absence of the *Co-Presidents* and shall perform such other duties assigned by the Board of Directors. *In the event that the office of Co-President becomes vacant between elections, the Vice President, elected first, hence the First Co-Vice President will fill the vacancy until the next scheduled AGM. If the First Vice-President is unable to serve, than the Second Vice President shall serve until the next scheduled AGM.*

**Section 8.8 “Secretary”. Amend to “Co-Secretaries”.**

**Section 8.9 “Treasurer”. Amend to “Co-Treasurers”.**
